

**Office of the State Selection Board,  
Department of Higher Education, Government of Odisha, Bhubaneswar.**

Proceeding No: 006/dated the 24<sup>th</sup> April, 2015.

The sixth meeting of the State Selection Board, Department of Higher Education, Government of Odisha, Bhubaneswar was held in the office Chamber of the Director, Higher Education, in the Heads of Department building on 24<sup>th</sup> April' 2015 at 11.30am. Presided over by the Director, Higher Education and President, SSB, Prof. Nihar Ranjan Patnaik along with the following members;

The meeting was started with a welcome address by the President SSB followed by a discussion on the proceedings of the last meeting, especially on the response of the 488 category of colleges on the subject wise vacancies in the sanctioned Direct Payment posts. The actions taken by the Secretary, SSB in connection with sending reminders to 146 defaulted colleges and sending confirmation request through e-mail to all other colleges were discussed and appreciated. The preparation relating to the initiation of the recruitment of lecturers against the vacant Direct Payment posts in the 488 category of non-government aided colleges as well as the vacant sanctioned posts in the SSB office and the problems of accommodation of SSB were discussed in detail and the following resolutions are unanimously adopted;

1. That, the Secretary, SSB is requested to inform the Department of Higher Education about the latest subject wise vacancies in the sanctioned Direct Payment Posts in the 488 category colleges received by SSB as on 24<sup>th</sup> April 2015.
2. That, the draft proposal on the procedure of selection of the lecturers against the vacant DP posts by the Secretary, SSB, with reference to the criteria adopted by different recruiting agencies were discussed and he is requested to personally contact local recruiting agencies, specially, Odisha Public Service Commission at Cuttack for some more details like; Distribution of Weightage, Age limit, Application Fees etc. and the same will be discussed in the next meeting for further ratification, if any.
3. That, the problems and the constraints of proper functioning of SSB due to non availability of adequate space was discussed in detail and the Board requested the Secretary, SSB to discuss the matter with the concerned officer in the Higher Education Department in this matter.
4. That, Higher Education Department be requested to carry out a special audit of SSB till 31<sup>st</sup> March 2015 by the appropriate audit authority.
5. That, the Higher Education Department be requested to make necessary provision for giving Accounts Training to the SO – cum – DDO of SSB.
6. That, the next meeting of the board is scheduled to be convened during the last week of May, 2015 or on any day in the month of May with a short notice, in case of any exigency.

The meeting ended with a vote of thanks proposed by the Secretary, SSB.
